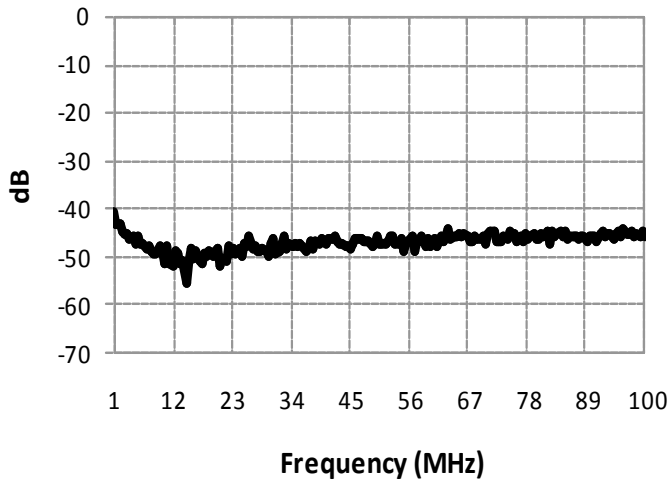
Insertion Loss



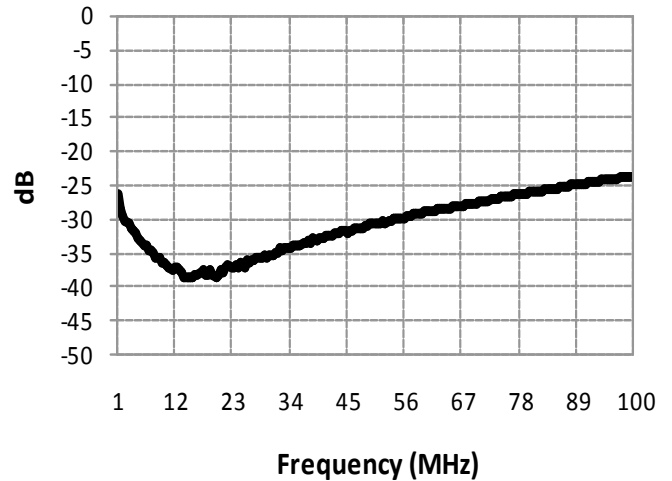
Input Return Loss



Differential to Common Mode Rejection

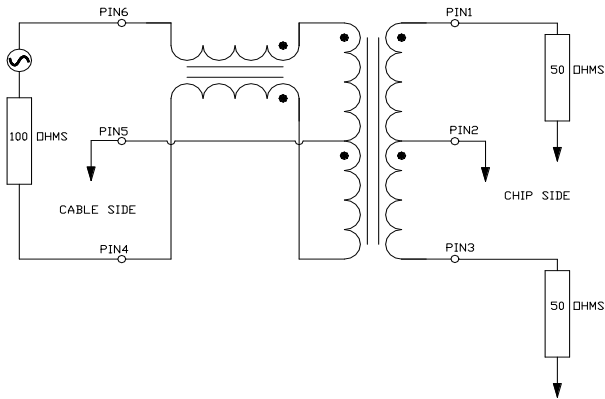


Output Return Loss

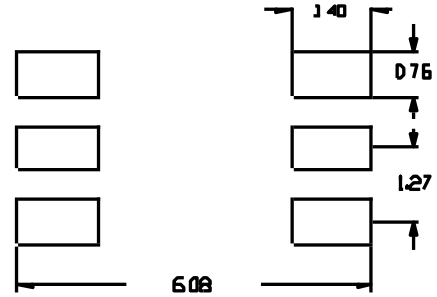

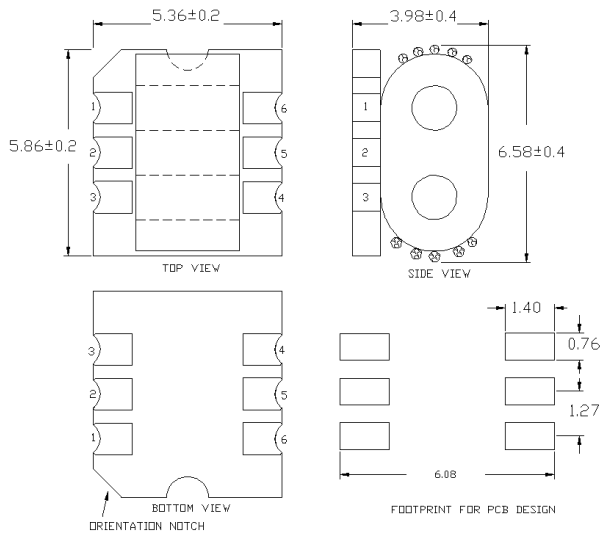
## Application Circuit
