


$V_{DS}$ , DRAIN-SOURCE VOLTAGE (V)  
Figure 1. Typical Output Characteristic




$V_{GS}$ , GATE-SOURCE VOLTAGE (V)  
Figure 2. Typical Transfer Characteristic




$I_D$ , DRAIN-SOURCE CURRENT (A)  
Figure 3. Typical On-Resistance vs. Drain Current and Gate Voltage









$V_{GS}$ , GATE-SOURCE VOLTAGE (V)

Figure 6. On-Resistance Variation with Temperature







Figure 13. Transient Thermal Resistance


